GENERALS

1. Accommodations include renting, for 4 or 6 people for a mobile home and 3 to 6 people for a caravan, car park for one vehicle, water, electricity, gas and access to camping's facilities.
2. Campsites are rent from 12h am to 12h pm during July and August.
3. For reservation's payment of a campsite, we accept bank cards, money orders, and cash . For transfer payment, consult us at 04.75.34.87.93.
4. The early discontinuation or reduction of the time of a stay for any reasons independent from camping « Du Bas Larin » give no right to a repayment.
5. We'll ask a security deposit of 300€ for the renting and its equipment and a security deposit for the cleaning (security deposit are paid by cheques or cash). An inventory of the place will be made at your arrival and your departure. The security deposit will be returned on your day of departure if the place is leaving as clean as you found it and without degradation.
6. Reservation become effective when the camping « du Bas Larin » has sent a copy of this agreement (as long as there are available campsites) following reception of this agreement signed and accompany by deposit. We offer an optional insurance FFC.
7. In case of force majeure's cancellation by letter 30 days before the arrival, the whole of the advance will be returned except files charges of 10€. After time, the camping shall retain the whole of the deposit.
8. Pets (except dogs which belongs in the 1st or the 2nd category) are free accepted as long as they are tattooed and vaccinated, they also have to be kept on a leach and the dog have to be take out for its walk outside the camping.
9. We thank you to, during your stay, respect rules which are put up the entrance and the desk of camping.
10. A stay tax of 0.33€ head by night will be ask for any people who is more than 13 years old.
11. Your visitors have to present themselves at the desk and pay the entrance before to go inside the camping.
12. Camping decline every responsibility in case of robbery, fire, bad weather etc...also in case of incident which is holiday maker's responsibility.
13. Every renting is personal and can't be sub-let or give.
14. In case of disputes, Tribunal of Privas is the only one competent.
